

DISCLAIMER

1. By signing this declaration, I – as a competent adult - hereby confirm that the use of go-carts and other equipment belonging **Power Racing ApS** is completely at my own risk.
2. I understand and respect that driving go-carts requires full concentration, physical strength and good behaviour. I therefore declare that I am in a good physical condition, and that I am not under the influence of alcohol, euphorants or medication in risk of making me unfit for driving go-carts. I am aware of the fact that driving go-carts may be dangerous and that people suffering from heart problems, increased blood pressure, pregnant women and people with back injuries may be at risk and are thus not allowed to drive go-carts at **Power Racing ApS**.
3. I understand and accept that I must follow all directions given to me by employees or representatives of **Power Racing ApS** during my visit to **Power Racing ApS**.
4. I understand and accept that I am liable for damage to the go-cart and other equipment used by **Power Racing ApS**, in case I act irresponsibly, cause malicious damage or disregard directions given to me by employees or representatives of **Power Racing ApS**.
5. I understand and accept that **Power Racing ApS** can NOT be held responsible for damage to my property caused by negligence or omission by Power Racing ApS or third party and that **Power Racing ApS** can NOT be held responsible for property, including clothes and valuables, lost in changing rooms as well as items lost/forgotten in the go-cart or on the track.
6. I understand and accept that **Power Racing ApS** can NOT be held responsible for personal injury that I cause on myself or on third party in connection with the use of the rented go-carts, including injuries occurring during my stay on and around the track in general.
7. I understand and accept that **Power Racing ApS** can NOT be held responsible for any personal injury that I may suffer due to negligent actions or omissions by **Power Racing ApS** or third party in connection with the use of go-carts etc. provided by **Power Racing ApS** (including injuries occurring during stay on or around the track in general).
8. I understand and accept that I cannot sue for remedy against **Power Racing ApS** for damages inflicted on me.
9. This disclaimer does not cover damages caused by malicious acts or omissions by **Power Racing ApS** (or employees and representatives hereof).
10. I understand and accept that if, despite the above, **Power Racing ApS** might be considered responsible, the maximum financial responsibility of **Power Racing ApS** is limited at DKK 25 million.
11. I understand and accept that the disclaimer above is also applicable to minors of whom I am responsible in case they might suffer or cause any kind of injury or damage on themselves or others in connection with the use of go-carts etc. provided by **Power Racing ApS** (including injuries or damage occurring during stay on or around the track in general).
12. **Power Racing ApS** is allowed to use e-mail for marketing its own products to the client through electronic mail.
13. We reserve the right to immediately exclude anyone who drives hazardously, is involved in collisions or damage to the carts and track. In this case, no fee will be refunded. Damage must be paid for immediately in cash.
14. Results are generated based on one's driving, which will be displayed on scoreboards in the center with first and surname.
15. Clubspeed (timing system) generates an automatic mail with the results of the heat you have driven. The mail will be sent to all those who have been driving in the concerned heat.
16. If you do not wish your information to be processed as mentioned in section. 14 and 15, please inform staff before driving.

PRIVACY POLICY

Below you can read what information we collect, how we treat the information collected, and who has access to it as well as contact information for Landholdet ApS/Power Racing Gokart Akademi (in short: PR)

1 | GENERAL TERMS

The collection of information through Club Speed is in compliance with the Danish legislation.

2 | PERSONAL INFORMATION

All personal data, collected during your visit, is treated in compliance with the legislation in force at the time in question.

PR handles all personal information, given at the time of purchase of products in order to honour a contract between you and PR. You register your name, phone number, email and date of birth when you wish to drive go-carts at PR. Your contact information is used in case we need to contact you in case of forgotten items or remedies. Your date of birth ensures that you are 18+ years old. The legal basis of the handling of the above is the honouring of a contract of which you are part, cf. the Danish General Data Protection Regulation article 6 subsection 1 litra b. The information is stored during your period as a client or minimum 3 years after the expiry of your contract.

The information is not treated in any way irreconcilable with its original purpose.

3 | STORAGE OF PERSONAL INFORMATION

Sensitive personal data in print is kept under lock when not in use. Access to information (electronic and physical) is limited to employees of the PR with actual need for the information.

When documents (papers, index cards, files etc.) holding sensitive personal information, is thrown away, they will be shredded or in other ways destroyed preventing unauthorized persons from gaining access to the information. If sensitive personal information is sent by email, it will be encrypted.

4 | DISCLOSURE OF PERSONAL INFORMATION

PR does not sell or rent your personal information to anyone. PR only passes on your information to others when:

- We have your full permission to do so.
- We are forced to share your information with others in order to provide the service you have asked for.
- We are forced to do so through court rulings, lawsuits or other law-enforced actions.
- If we believe that your actions on our website violates PR's rights concerning use of the website.

5 | RETRACTION, RETRIEVAL AND DELETION OF INFORMATION

At all times, you remain the rights to:

- Be informed of the personal information registered on you.
- Rectify incorrect information about you.
- Move your registered information to a third party.
- Request deletion of your information.
